	Adds Revocation Appeal process (para 2-2g).
	Adds that all permit holders and other non-hunting/fishing recreationalists are required to have an activity card displayed in the passenger side windshield, regardless of the activity (para 2-2j).
	Requires hunters, trappers, anglers, and non-hunting/fishing recreationalists to only access Fort McCoy training areas from Fort McCoy established roadways open to motor vehicle traffic. Entering Fort McCoy by walking or driving over berms from adjacent properties is prohibited (para 2-2m(1)).
	Requires all tree stands to be equipped with a certified safety harness and hunters must use the harness

□ Allows the use of motorized transportation/equipment while hunting on Fort McCoy only if the hunter is hunting under a WDNR disabled hunting permit and proper safety equipment is worn (para 2-2x).

Restricts the use of game cameras to 1 September – 31 May (para 2-2y).
Moves the prohibited activities from 2-1m to 2-3a.
Adds the following activities to the General Prohibited Activities: use of any Unmanned Aerial Vehicles (UAV) or drones for hunting/fishing/trapping/non-hunting/fishing recreational purposes; purposeful introduction of any plants, animals, or fish to Fort McCoy; discard or dumping of animal carcasses, skins, bones, or parts within any open or closed areas (field dressing is allowed); and biking/mountain biking off of established roads/trails (para 2-3a(21-24)).
Adds that all persons that are participating in hunting activities, are not allowed into the training areas until times outlined under their specific activity (para 3-1d, 3-2d, 3-3d, 3-4d, 3-5d, 3-6d, and 3-7d).
Removes Black Out Drive requirements.
Extends the Archery and Cantonment Archery seasons to follow the Wisconsin Archery season dates (para 3-3c and 3-4c).
Allows Cantonment Archery hunting during the Gun-Deer Hunt for Hunters with Disabilities and the Gun-Deer seasons. Cantonment Archery hunters are require to wear blaze orange while hunting in Training Areas G-1, D-10W, and D10-E during these seasons (para 3-4c(2)).
Adds that Archery and Cantonment Archery hunting is closed the day before the Gun-Deer season (para $3-3c(2)$ and $3-4c(1)$ ).
Requires all deer harvested during the Gun-Deer or the Gun-Deer Hunt for Hunters with Disabilities seasons to be brought by the Deer Data Collection Point (DDCP) for collection of biological data (para 3-5g and 3-6h).
Allows the use of bows and crossbows during the Gun-Deer season. The use of archery equipment is only allowed under the authority of a Fort McCoy Gun-Deer permit and a Wisconsin Gun-Deer license (para 3-5h).
Adds that the WDNR FREE 2018 Farmland (Zone 2) Antlerless Tags no longer needs to be Monroe County or public land specific for hunters participating in the Gun-Deer Hunt for Hunters with Disabilities season (para 3-6f).
Changes submission of a weekly trapping map to a requirement for a map depicting the general area where traps are located and the number of traps at the start of trapping and updated maps if traps are moved or added (para 3-8d).
Changes the weekly trapping report requirement to an annual report due at the end of the trapping season (para 3-8d).
Requires all anglers to sign-in/out for fishing, select a zone they will be entering, and check the Gameline for closures through the iSportsman system (para 3-9c).
Outlines procedures to access lakes and streams for fishing (para 3-9e(1-2)).
Adds that floats and kayaks are <u>NOT</u> allowed on Stillwell Lake, Swamp or Sparta Ponds and they must comply with Wisconsin Boating Regulations (para 3-9h).
Restructures Appendix A IAW FMM 25-52 guidelines.
Updates Fort McCoy Regulation 190-5, Installation Access Control and Traffic Code to Fort McCoy Pamphlet 190-13.8 (Appendix A).

#### **HUNTING, FISHING, TRAPPING RULES AND REGULATIONS**

**HISTORY.** This is the eleventh revision to Fort McCoy Regulation 420-29, Hunting, Fishing, Trapping Rules and Regulations.

**SUMMARY.** This regulation sets forth rules and regulations for all hunting, fishing, trapping and select non-hunting/fishing activities on Fort McCoy.

**APPLICABILITY.** This regulation is applicable to all activities on Fort McCoy. Civilian, military, tenants, and training units are required to comply with this regulation. No activity is exempt from this regulation.

**PROPONENT EXCEPTION AUTHORITY.** The proponent of Fort McCoy Regulation 420-29 is the Directorate of Public Works (DPW), Environmental Division, Natural Resources Branch (NRB). **SUPPLEMENTATION.** Supplementation of this regulation is prohibited without prior approval from the proponent.

## Chapter 1

## 1.1 Purpose

This regulation establishes rules and regulations enforceable in federal court for hunting, fishing, trapping, and select non-hunting/fishing/trapping activities on Fort McCoy. This regulation promotes the management of these activities and populations of fish and game on Fort McCoy. If this regulation conflicts with State of Wisconsin hunting, fishing and trapping regulations or other federal or state directives, such conflicts will be brought promptly to the attention of the Directorate of Public Works, Environmental Division, Natural Resource Branch (NRB), (IMMC-PWE-N), 2171 South 8th Avenue, Fort McCoy, WI 54656-5136.

#### 1-3. Explanation of Abbreviations and Terms

#### 1-4. Responsibilities

- a. Natural Resources Branch (NRB): The mission of the Fort McCoy NRB is to foster the wise stewardship of natural and cultural resources which will support and sustain a realistic military training environment, biological diversity, the integrity of sensitive or unique sites, and commercial and recreational opportunities. The NRB is the proponent of this regulation.
- b. Installation Legal Office (ILO): Fort McCoy ILO provides legal advice concerning all matters governed by this regulation.
- c. Directorate of Emergency Service (DES): Fort McCoy DES is responsible for providing fire and medical emergency response, enforcement of law and regulations, and 911 emergency communications support. Call 911 for all emergencies and state you are located on Fort McCoy; for non-emergencies and/or to report a violation, call (608) 388-2266.
- d. Directorate of Plans, Training, Mobilization, and Security (DPTMS): Fort McCoy DPTMS is responsible for training area management and updating the Game Line within iSportsman.
  - e. Permit Holder:
- (1) It is the responsibility of the individual recreational participant/permit holder to check the Game Line using iSportsman at (866) 277-1597, online at <a href="https://www.mccoy.isportsman.net">www.mccoy.isportsman.net</a>, or through the kiosk located at the Hunter Information Point (HIP) for updates, changes, and/or temporary regulations to the activities associated with this regulation. Game Line information must be checked daily to ensure that the activity has not been restricted because of unforeseen mission requirements.
- (2) Maintain strong hunter and land ethics to ensure quality hunting experiences can continue for future generations.
  - (3) Read and follow these rules and regulations and any changes.

#### Chapter 2

#### 2-1. General Installation Access and Information

- a. Firearms Registration: All firearms brought on to the installation for any purpose must be registered through the Fort McCoy Police. This requirement pertains to anyone with a firearm in their possession while on Fort McCoy for any reason including hunting, fishing, trapping, camping, shooting range, or visiting members of the Fort McCoy community or staff. Firearm is defined as: any weapon (including a starter gun, weapon frame or receiver) which will, or is designed to or readily be converted to, expel a projectile by the action of an explosive or other propellant. Questions related to firearms registration should be directed to the Fort McCoy Physical Security Division at (608) 388-2266.
- b. Transportation of Firearms, Bows, and Crossbows: While on Federal property all firearms, bows, and crossbows must be unloaded and completely enclosed in a case designed to carry a firearm, bow, or crossbow when in or on any vehicle, whether moving or stationary. Bows and crossbows must be unstrung if not enclosed within a case. Weapons are not allowed to be loaded in or on a vehicle at any time with the exception for WDNR Disabled Class A and B Permit hunters while stationary. **Concealed Carry is prohibited on Federal Property**.

- c. Visitor pass: All visitors entering the Fort McCoy Cantonment Area must obtain a visitors pass at the Visitor Control Center. After business hours visitor passes must be obtained at the Main Gate or gate 20. Visitors that have a federally issued Common Access Card (CAC) or a retired military or dependent ID card do not need a visitor pass. Questions related to visitor passes should be directed to the Fort McCoy Physical Security Division at (608) 388-2266.
- d. Vehicle search: Owners and/or operators of motor vehicles that enter the property of Fort McCoy consent to the search of their motor vehicle.
  - e. Alcohol: It is not permitted to be intoxicated or to consume alcohol while in training areas.
- f. Speed limits: The speed limit on Fort McCoy is 30 miles per hour (MPH) in the Cantonment Area, 10 MPH when passing troops and 45 MPH in the training areas, unless otherwise posted.
- g. Reporting of information: All personnel on Fort McCoy are required to notify the Fort McCoy Police at (608) 388-2266 of any observed violations of Federal or State laws, Fort McCoy rules and regulations, uncontrolled fires, or the location of any found unexploded ordnance.
- h. Conduct: All personnel on Fort McCoy will cooperate with military officials and Fort McCoy Police personnel. In addition to the appropriate permits, all persons 18 years old or older must have an official picture identification in their possession at all times while on Fort McCoy property.
- i. Unexploded Ordnance (UXO) Hazard: Military training involving live ammunition and explosives has occurred throughout Fort McCoy since 1909. Deliberate and comprehensive efforts have been conducted to clear the UXO hazards; however, these items may occasionally still be encountered while on Fort McCoy.
- (1) UXOs are often referred to as duds, bombs, munitions, ordnance, ammo, dummy rounds, or by other terms. Regardless of what they are called, they should be considered extremely dangerous. They were designed to explode and still have the capability to do so. Never touch, move, or disturb munitions. Even Civil War cannon balls and souvenir munitions that may have been handled for years can potentially detonate at any time.
- (2) UXOs come in many shapes and sizes and may be visible on the surface or buried. They can be exposed by erosion or fires, and may look new or old. UXOs may also be found alone or in groups; and can be whole or in parts.
- (3) Anyone encountering or believing they may have encountered UXOs should consider them extremely dangerous. The proper response to avoid injury to themselves and others is to follow the 3Rs of explosives safety:
- (a) Recognize recognizing when you may have encountered UXO is key to reducing the risk of injury or death. If you encounter or suspect you may have encountered UXO, consider it extremely dangerous. Remember, UXO is sometimes hard to identify.
- (b) Retreat if you encounter or suspect you may have encountered UXO, do not touch, move or disturb it, but immediately and carefully leave the area following the same path on which you entered. If you can, mark the general area, not the UXO, in some manner (e.g., with a hat, piece of cloth, or by tying something to a tree branch).
- (c) Report notify Fort McCoy Police at (608) 388-2266 of what you saw, where you saw it, the type of markings, and if you were able to mark the area. These actions will protect you and others who may encounter the same area.
- (4) Additional UXO safety information and a photo gallery of various types of UXO are available from the Department of Defense (DoD) internet site at <a href="https://www.denix.osd.mil/uxo/SafetyTopics/UXO.cfm">www.denix.osd.mil/uxo/SafetyTopics/UXO.cfm</a>.
- j. Archaeological resources: It is a federal offense to dig, excavate, disturb the ground, and/or collect archaeological artifacts on Fort McCoy without authorization from the DPW and pursuant to a permit issued under the Archaeological Resources Protection Act of 1979. Violators are subject to criminal penalties involving fines and/or imprisonment and civil fines and forfeiture of vehicles and equipment used in connection with a violation (reference Archaeological Resources Protection Act of 1979, 16 USC 470, and 36 CFR 261.9). The discovery of any artifact should be reported to the NRB at (608) 388-8214.
- k. Land Rehabilitation and Maintenance (LRAM): The LRAM program is responsible for the repair and re-vegetation of selected trails and sites within the training areas. The LRAM sites are clearly marked with red and white signs and/or yellow LRAM tape and shall not be disturbed. LRAM sites are OFF LIMITS to vehicles, however foot traffic is allowed. Be advised unknown obstacles and dangers may exist in and around signed LRAM areas.

#### 2-2. Hunting, Fishing, Trapping and Non-Hunting/Fishing Activities and General Regulations

- a. Permit Requirements: The appropriate Fort McCoy iSportsman access pass, hunting, fishing, trapping, non-hunting/fishing activity permit, <u>and</u> appropriate State of Wisconsin license and stamps are required to hunt, fish, or trap on Fort McCoy. **Fort McCoy permits are not transferable or refundable.**
- b. Revenue: Revenue from the sale of hunting, fishing, and trapping permits remains on Fort McCoy and is used for the management of fish and wildlife populations and habitat.
- c. Permit Sales: Fort McCoy Hunting, Fishing, and Trapping permits are sold through the Fort McCoy iSportsman website at <a href="https://www.mccoy.isportsman.net">www.mccoy.isportsman.net</a>, at the Pine View Campground Office, or at the Permit Sales Office (PSO). The PSO, Building 2168 South 8th Avenue, is open Monday-Friday, 7:00 a.m. to 3:30 p.m. The appropriate State of Wisconsin licenses, permits, and stamps can be purchased through the WDNR GoWild online system or at any authorized WDNR GoWild vendor throughout Wisconsin.
- (1) Fort McCoy Access Pass is required for all activities to include hunting, fishing, trapping, and non-hunting/fishing activities. A Fort McCoy Access Pass can be obtained through the iSportsman system by visiting <a href="https://www.mccoy.isportsman.net">www.mccoy.isportsman.net</a>, Pine View Campground Office, or the Permit Sales Office (PSO). All recreational users need to update their account annually by adding the current license year Fort McCoy Access Pass. The Fort McCoy Access Pass is valid from March 1 through February 28 every year. A Fort McCoy Access Pass serves as the permit for non-hunting/fishing recreational activities outlined in paragraph 3-10.
- (2) Non-quota season permits (i.e., Fishing, Archery, Fall Turkey, and Small-Game) can be purchased directly through your account in iSportsman. **A Fort McCoy application is not required to purchase these permits.**
- (3) Quota season permits (i.e., Gun-Deer, Gun-Deer Hunt for Hunters with Disabilities, Cantonment Archery, Spring Turkey, and Trapping) are **only** available through the Fort McCoy online application process. Quota permit applications are only available through the Fort McCoy iSportsman website at <a href="https://www.mccoy.isportsman.net">www.mccoy.isportsman.net</a>. Selection is conducted through a random drawing following the application deadline date. All applicants are notified of the selection results through the iSportsman system and can check the status of their application through their iSportsman account. Individuals approved for a quota permit(s) are provided instructions on how to purchase their permit(s).
- (4) Soldiers stationed at Fort McCoy after the quota permit drawing has been completed are eligible to apply for a quota permit (i.e., Gun-Deer, Gun-Deer Hunt for Hunters with Disabilities, Cantonment Archery, Spring Turkey, and Trapping). Soldiers must contact the Permit Sales Office (PSO) for information on the application process and hand deliver a copy of their Permanent Change of Station (PCS) orders showing the date of assignment after the application period. For further information contact the PSO at: Directorate of Public Works, (IMMC-PWE-N/Permit Sales), 2171 South 8th Avenue, Fort McCoy, WI 54656-5136, by email: <a href="mainto:usarmy.mccoy.imcom-central.mbx.dpw-permit-sales@mail.mil">usarmy.mccoy.imcom-central.mbx.dpw-permit-sales@mail.mil</a>, or by phone: (608) 388-3337. The PSO, 2168 South 8th Avenue, is open Monday-Friday, 7:00 a.m. to 3:30 p.m.
- d. Mentorship Program: Fort McCoy allows youth ages 10 and 11 to participate in all hunting seasons under the WDNR Mentorship Program. Mentors must possess a current year's Fort McCoy hunting permit and Wisconsin hunting license. The type of license does not matter unless the mentor will also be attempting to harvest the same type of game. Mentees must possess a valid Fort McCoy permit and Wisconsin hunting license for each hunting season they intend to participate in. Only one weapon per valid Fort McCoy permit is allowed, if both the mentor and mentee have valid permits and licenses, both the mentor and mentee are allowed to possess a weapon. Both the mentor and mentee must sign-in/sign-out daily. All participants must follow this regulation and the WDNR guidelines and rules associated with the program.
- e. Regulations/Maps: Fort McCoy Hunting, Fishing and Trapping regulations and maps are available at the PSO, online at <a href="www.mccoy.isportsman.net">www.mccoy.isportsman.net</a>, the Pine View Campground, and at the HIP. In addition to this regulation, all State of Wisconsin Hunting, Fishing, and Trapping Regulations are applicable on Fort McCoy except as indicated in this regulation. Violation of either the Wisconsin Hunting, Fishing, or Trapping regulations or this regulation may result in any or all of the following:
  - (1) Criminal prosecution in Federal Magistrate Court.
  - (2) Fines and/or forfeiture in U.S. District Court.
- (3) Suspension or revocation of Fort McCoy hunting, fishing, trapping, non-hunting/fishing activities, and/or firewood cutting privileges either immediately or by written notification (reference appendix B). (4) Written warning.

- (5) Disciplinary action under the Uniform Code of Military Justice (UCMJ) for persons subject thereto.
- f. Violations: Violations by an individual of three or more offenses covered by Federal Fish and Wildlife Regulation (Code of Federal Regulations (CFR) or U.S. Code (USC)), State of Wisconsin Hunting/Trapping/Fishing Regulations and/or this regulation may subject the individual to permanent revocation of Fort McCoy hunting, fishing, trapping, and firewood cutting privileges. If your privileges have been revoked or suspended for a violation, ALL privileges, to include hunting, fishing, trapping, non-hunting/fishing recreational activities and firewood cutting will be revoked or suspended. Non-hunting related violations resulting in an individual being barred from Fort McCoy will also result in the loss of all hunting, fishing, trapping, and firewood cutting privileges for the same period. Any violation associated with the Cantonment Archery season regulation will subject the individual to permanent revocation of Cantonment Archery hunting privileges and may include additional revocation of privileges, to include hunting, fishing, trapping, and firewood cutting.
- g. Revocation Appeal: Temporary or permanent revocation of privileges are based on the police report, seriousness of the violation, number of violations, and any extenuating circumstances. A letter of revocation will be provided to the violator by the Fort McCoy Police. Revocations can be appealed in writing through the PSO. Requests will be processed within 30 days of receipt. Contact the PSO for more information.
- h. iSportsman Automated System: The iSportsman automated system provides recreational participants/permit holders the ability to use either the internet, a telephone (land line, cell phone, or smartphone), or at the HIP\_kiosk to: purchase a Fort McCoy permit, sign-in/sign-out for an activity; access Game Line updates; and update iSportsman account information. Anyone participating in an activity must register/create an account in iSportsman, and use that account during sign-in/sign-out while participating in any activities on Fort McCoy. This is a one-time registration, if you forget your username/permit number or password/PIN, contact the PSO to get it reset instead of creating an additional account. To access iSportsman, call (866) 277-1597, visit <a href="www.mccoy.isportsman.net">www.mccoy.isportsman.net</a> online, or visit the kiosk located at the HIP (identified on the hunting, trapping, and fishing maps). The iSportsman permit number will serve as your Fort McCoy customer identifier through iSportsman and must be used when signing into a zone.
  - i. Requirements for sign-in/sign-out:
- (1) All recreational participants/permit holders are required to sign-in/sign-out daily for all 2018 recreational seasons by calling iSportsman at (866) 277-1597, online at <a href="www.mccoy.isportsman.net">www.mccoy.isportsman.net</a>, or through the kiosk located at the HIP. Recreational participants/permit holders are required to select one of six hunting zones (see maps at appendices C, D, E, and G for zones) in which they intend to enter. Only one zone can be selected at a time. Recreational participants/permit holders may change zones by signing-out of the initial zone they signed-in for, and then signing-in for the next zone they will be using. Recreational participants/permit holders must still ensure that the training area(s) and/or lake(s) they plan to utilize within the zone are open. See specific hunting/trapping season for harvest registration and reporting procedures.
- (2) The HIP, as identified on the Fort McCoy Hunting, Fishing, and Trapping Maps (appendices C, D, E, F, and G), and iSportsman website (<u>www.mccoy.isportsman.net</u>) will provide information to hunters/anglers/trappers as outlined in this regulation. The HIP is located along of Highway 21 at the intersection of South J Street and Highway 21 and will be open for **all** hunting/fishing/trapping seasons.
- j. Activity Information Card: All recreational participants/permit holders are required to display an information card on the passenger side of the windshield/dash with the following information: Permit holder's full name (if there is more than one permit holder per vehicle, the names of all permit holders will be noted), activity (Spring Turkey, Fishing, Cantonment Archery, Archery, Gun-Deer Hunt for Hunters with Disabilities, Gun-Deer, Small Game, Fall Turkey, Trapping, Scouting, berry picking, bird watching, etc.), personal cell phone number and two emergency contact phone numbers for each permit holder in the vehicle.
- k. Game Line: The Game Line, accessed by calling (866) 277-1597, online at <a href="https://www.mccoy.isportsman.net">www.mccoy.isportsman.net</a>, or on the kiosk located at the HIP, lists training areas and lakes that are closed on any particular day. The Game Line listing will be updated by DPTMS. Fort McCoy reserves the right to update training area closures at any time if needed. **ALL** individuals are required to check the Game Line **daily** for any changes.
- I. Open Training Areas: Hunting or tracking wounded game into the North Impact Area or onto any ranges within the North Impact Area is <u>forbidden</u> under any circumstances. Not all training

areas on the installation are open on a given day. Individuals found in closed training areas are subject to prosecution. Check the Game Line daily for a list of closed training areas. Fort McCoy reserves the right to adjust training area closures as needed to facilitate military training or game management operations. Scouting is not allowed in areas being used during the Gun-Deer Hunt for Hunters with Disabilities on October 6-7, 2018.

- m. Access to Training Areas:
- (1) Hunters may only access Fort McCoy training areas from established Fort McCoy roadways open to motor vehicle traffic. Entering Fort McCoy by walking or driving over berms from adjacent properties is prohibited and will result in fines and/or suspension/revocation of hunting, fishing, trapping and firewood cutting privileges.
- (2) Driving on or over berms to access or move around an area is **not allowed**. Parking vehicles on roads or trails in a manner that blocks additional vehicles from passing is **prohibited**.
- (3) Permit holders cannot drive on trails or walk in closed training areas to access an open training area.
- n. Restricted areas: Several training areas have access restricted to active duty and retired military personnel or their dependents and a guest and several have restrictions on the type of weapon that may be used for various hunting seasons. **These training areas are noted on the hunting maps** (appendices C and D).
- o. Tracking wounded game: Hunting or tracking wounded game into the North Impact Area or onto any range within the North Impact Area is **prohibited** under any circumstance. Hunters may not track wounded game into any closed area unless accompanied by Fort McCoy Police, contact (608) 388-2266 for assistance. If a wounded deer or other game goes off the installation, it is the hunter's responsibility to obtain permission from the landowner to enter their property.
- p. Tree stands: All tree stands must be equipped with a certified safety harness. Hunters must use the safety harness while occupying the tree stand. Elevated structures including climbing tree stands may be used on the installation providing they do not damage the tree and are completely removed each day at the close of hunting hours. Hunters are not allowed to construct or hunt from permanent tree stands. Tree spikes and screw-in steps are not allowed. The cutting of any live trees or shrubs, over one inch in diameter, is not allowed to create shooting lanes.
- q. Commercial and man-made hunting blinds: All commercial blinds must be removed daily by the end of hunting hours. The cutting of any live trees, tree limbs, or shrubs over one inch in diameter is not allowed to construct or conceal any hunting blind. Commercial and man-made (constructed of natural materials in the field) blinds used during any Gun-Deer season must display at least 144 square inches of solid blaze orange material visible from all directions around the blind. Blaze Pink is not allowed. 144 square inches of Blaze Orange are not needed during Archery, Spring Turkey, or Fall Turkey seasons.
- r. Individuals are not allowed to hunt within 50 feet from the center of, or shoot across any main roads. (reference appendices C & D for maps).
  - s. Hunting at night is not allowed.
- t. Coyote hunting: Coyote hunting is not allowed during the Gun-Deer or Gun-Deer Hunt for Hunters with Disabilities seasons. Coyote hunting with the use of dogs is limited to South Post only (south of Highway 21). Any coyotes harvested on Fort McCoy must be reported through iSportsman to assist the Fort McCoy Wildlife Program with record keeping and population management.
- u. Deer drives and group hunting: Hunting parties (groups) may not exceed 10 people when conducting deer drives. Deer drives are prohibited during the early Archery season, the first two days of the Gun-Deer season, and within the Cantonment Area. Those found conducting deer drives not in accordance with Fort McCoy rules and regulations will be subject to prosecution. A deer drive is defined as an organized activity including two or more individuals hunting together (group) where one or more members of the group are hunting with the intent of driving (moving) deer past another member or members of the group who are positioned in a pre-determined location(s) to shoot at the deer. Hunters are prohibited from entering closed training areas to drive game animals out of the closed training areas into open training areas. All hunters participating in deer drives on Fort McCoy must possess a valid Fort McCoy deer hunting permit (i.e., Archery, Gun-Deer, Gun-Deer Hunt for Hunters with Disabilities) for the season they are hunting. Group/party hunting or filling another hunters' (who is/are within eye sight or shouting distance) tag is allowed only during the Gun-Deer and Gun-Deer Hunt for Hunters with Disabilities.
  - v. Baiting and feeding wildlife: Due to health concerns and the potential spread of disease in deer and

other wildlife species, the use of baits on Fort McCoy to attract animals to a specific location is not authorized. Baiting is allowed while trapping or conducting official government studies. The planting of food plots, without proper authorization, is strictly prohibited.

- (1) Bait is defined as any feed material that is placed or used to attract wild animals, including salt, minerals, fruit/vegetable, grains, liquids, etc.
- (2) Scent material, to include cover scent, may be used during deer hunting seasons, but must not be placed or deposited in a manner to allow consumption by wildlife and must be removed daily.
- (3) Hunting is allowed over/near naturally occurring food sources. These materials cannot be moved from their specific location to attract wildlife.
- (4) Bird feeders may be used on Fort McCoy if the device is at a sufficient height and/or design to prevent access by deer and is within 50 yards of a dwelling.
- w. Cantonment Archery hunting: Archery hunting may be allowed in the Cantonment Area to Cantonment Archery permit holders only. Refer to paragraph 3-4 for further information and appendix F for a map of hunting areas. **Crossbows are not authorized in Cantonment Archery hunting areas.**
- x. No motorized transportation/equipment (defined as any motorized cart/carrier/wheeled machine aiding a permit holder to maneuver more easily) may be utilized while hunting/fishing/trapping on Fort McCoy to include: All Terrain Vehicles (ATV), Utility Terrain Vehicles (UTV), side-by-sides, golf carts, snowmobiles, lawn tractors, motorized carriers, etc., unless used under a WDNR disabled hunting permit. Proper safety equipment (helmet, protective clothing, foot protection, and eye protection) must be worn.
- y. Scouting cameras: The use of scouting cameras to track game species movement (e.g., deer, turkey, coyote, etc.) is only allowed in Fort McCoy training areas between September 1 through May 31, unless the camera is being used for an approved activity (i.e., research) and approved by the NRB. Placement within the Cantonment Area is allowed at any time. Scouting cameras can only be placed and checked when the training areas are listed as open on the Game Line. Scouting cameras must bear the name and address or WDNR customer identification number of the owner or operator permanently attached or engraved to the outside of the camera so that it is clearly visible without the need to move or adjust the camera. Fort McCoy is not responsible for lost, stolen, or damaged scouting cameras placed on the property. Baiting is not allowed to attract wildlife to the scouting camera site.

#### 2-3. General Prohibited Activities

Prohibited activities: Within the boundaries of the installation and without prior authorization, it is unlawful to:

- a. Pick up, disturb, carry off, or damage government equipment, ordnance, munitions or parts of the same.
  - b. Litter.
- c. Start fires (charcoal grills are allowed only in designated areas of the Pine View Campground and Cantonment Area).
  - d. Camp overnight, except at Pine View Campground.
  - e. Shine wild animals with artificial light at any time.
  - f. Hunt bear or wolves.
  - g. Drive vehicles onto ranges and/or hunt from towers/structures.
- h. Operate all-terrain vehicles/utility-terrain vehicles (ATV/UTVs) at any time or operate any other mechanized/motorized device to access the training areas or to retrieve downed game, unless approved under a disabled permit.
  - i. Operate snowmobiles to access training areas, unless on designated snowmobile trails.
  - j. Operate vehicles, ATV/UTVs, and snowmobiles on frozen lakes, ponds, rivers or streams.
  - k. Possess air guns, slingshots or spring loaded devices.
- I. Molest or take any non-game species (Except feral pigs, which may be taken with any Fort McCoy hunting permit. Any feral pigs taken must be reported to the NRB, Wildlife Program (608) 388-5374 or (608) 388-3337 before leaving Fort McCoy).
  - m. Ride horses.
  - n. Collect archeological artifacts.
- o. Collect reptiles, amphibians, or invertebrates without the appropriate collectors permit and approval from the Fort McCoy NRB.

- p. Use metal detectors (except at Pine View Campground beach).
- q. Carry a concealed weapon on Federal property.
- r. Collect native seed, pine cone, mast; collect cuttings for propagation; or dig/remove plants/trees from Fort McCoy for the purpose of transplanting species off post.
  - s. Bait or feed wildlife. Exceptions are outlined in paragraphs 2-2v.
  - t. Cut Christmas trees.
- u. Use any Unmanned Aerial Vehicles (UAV), or drones, for hunting/fishing/trapping/non-hunting/fishing recreational purposes.
  - v. Purposefully introduce any plants, animals, or fish to Fort McCoy.
- w. Discard or dump animal carcasses, skins, bones, or parts within any open or closed training areas. General field dressing/discarding of entrails prior to removing game animals from Fort McCoy is authorized
  - x. Biking/Mountain biking off of established roads/trails.

#### Chapter 3

## **3-1. Small Game Regulation**: refer to appendix C for map.

- a. Permits: A Fort McCoy Small Game hunting permit **and** appropriate WDNR hunting license are required. The procedure to purchase a Fort McCoy Small Game permit is outlined under paragraph 2-2c(2). Waterfowl can be hunted under a Fort McCoy Small Game permit.
- b. Sign-in/sign-out: All Small Game hunters must select the zone they intend to hunt and are required to sign-in and sign-out daily through iSportsman, reference paragraph 2-2i(1) for sign-in/sign-out procedures. The iSportsman system can be accessed by: calling (866) 277-1597, visiting <a href="https://www.mccoy.isportsman.net">www.mccoy.isportsman.net</a> online, or at the kiosk located at the HIP (see map at appendix C for zones, training areas and restricted areas).
- c. Seasons: Except as specifically stated in this regulation, the Small Game seasons on Fort McCoy are the same as the State of Wisconsin. Hunting for coyote, crow, snowshoe hare, and unprotected species ends on February 28. **Small Game hunting is not allowed from March 1 August 31.**
- (1) Small Game hunting (to include scouting) is closed in all areas north of Highway 21 during the Gun-Deer Hunt for Hunters with Disabilities on October 6 - 7, 2018.
- (2) Small Game hunting is closed on November 16, 2018 for Gun-Deer season preparations and scouting.
- (3) Small Game hunting, including waterfowl, is not allowed on Fort McCoy during the Gun-Deer season (November 17 November 25, 2018).
- d. Entry and hunting hours: **Entrance into Fort McCoy training areas is not permitted until 5:00 a.m. each day. Hunting at night is not allowed**. Reference State of Wisconsin Small Game Hunting Regulations for legal hunting times.
- e. Coyote hunting with the use of a dog is limited to South Post (south of Highway 21) only. Hunters are not allowed in closed training areas unless accompanied by Fort McCoy Police. Call Fort McCoy Police at (608) 388-2266 if assistance is required.
- f. Registration and reporting: All coyotes harvested on Fort McCoy must be reported through the iSportsman sign-out process to assist the Fort McCoy Wildlife Program with record keeping and population management.

#### **3-2. Fall Turkey Regulation**: refer to appendix C for map.

- a. Permits: A Fort McCoy Fall Turkey hunting permit, the appropriate Wisconsin hunting license (i.e., current Fall Turkey Hunting License, Conservation Patron License or a Senior Citizen Recreation Card), and Turkey Stamp are required. Conservation Patron License and Senior Citizen Recreation Card holders are exempt from the stamp requirement. The procedure to purchase a Fort McCoy Fall Turkey permit is outlined under paragraph 2-2c(2). All persons must reference the Wisconsin Fall Turkey Hunting Regulations for additional license information. Fort McCoy is a separate unit and is not part of Zone 1. Wisconsin Turkey Permits for Zone 1 are not valid on Fort McCoy.
- b. Sign-in/sign-out: All Fall Turkey hunters must select the zone they intend to hunt and are required to sign-in and sign-out daily through iSportsman, reference paragraph 2-2i(1) for sign-in/sign-out procedures. The iSportsman system can be accessed by: calling (866) 277-1597, visiting

<u>www.mccoy.isportsman.net</u> online, or at the kiosk located at the HIP (see map at appendix C for zones, training areas and restricted areas).

- c. Season: The Fort McCoy Fall Turkey season dates are the same as the Wisconsin Fall Turkey season dates.
- (1) The Fall Turkey hunting season (to include scouting) is closed in all areas north of Highway 21 during the Gun-Deer Hunt for Hunters with Disabilities on October 6 7, 2018.
- (2) Fall Turkey hunting is closed on November 16, 2018 for Gun-Deer season preparations and scouting.
- (3) Fall Turkey hunting is not allowed on Fort McCoy during the Gun-Deer season (November 17 November 25, 2018).
- d. Entry and hunting hours: **Entrance into Fort McCoy training areas is not permitted until 5:00 a.m. each day.** Reference State of Wisconsin Fall Turkey Hunting Regulations for legal hunting times.
- e. Harvest limit: Harvest is limited to two turkeys of any age or sex with the purchase of the 2019 Fort McCoy Fall Turkey Permit. The two Fort McCoy Fall Turkey harvest authorizations will be issued to your iSportsman account. **WDNR issued fall turkey tags/harvest authorizations are not valid on Fort McCoy**.
  - f. Hunting blinds: Refer to paragraph 2-2q for rules and regulations regarding hunting blinds.
- g. Registration and reporting: Fort McCoy has established online and phone-in registration for the Fall Turkey season through the Fort McCoy iSportsman system. Fort McCoy Fall Turkey hunters are required to report/register their harvested turkey(s) during the iSportsman check-out process. Hunters may be asked to provide a confirmation number by state law enforcement or meat processors, the confirmation number will **NOT** be provided during the check-out process and is the hunters' responsibility to create the confirmation number. The confirmation number will be made up of the hunters six digit Fort McCoy permit number (XXXXXX) and six digit date of harvest/registration (MMDDYY). The confirmation number will be 12 digits long and in the format described above (XXXXXX-MMDDYY). **Once your Fort McCoy harvest is reported through iSportsman your registration is complete and there is NO Requirement to also report your harvest through the WNDR registration system**.

#### **3-3. Archery Regulation**: refer to appendix C for map.

- a. Permits: A Fort McCoy Archery permit **and** Wisconsin Archer or Crossbow hunting license are required to hunt on Fort McCoy. WDNR Archer/Crossbow upgrades to existing licenses are also required if Archery hunters would like to use either weapon type. The procedure to purchase a Fort McCoy Archery permit is outlined under paragraph 2-2c(2).
- b. Sign-in/sign-out: All Archery hunters must select the zone they intend to hunt and are required to sign-in and sign-out daily through iSportsman, reference paragraph 2-2i(1) for sign-in/sign-out procedures. The iSportsman system can be accessed by: calling (866) 277-1597, visiting <a href="https://www.mccoy.isportsman.net">www.mccoy.isportsman.net</a> online, or at the kiosk located at the HIP (see map at appendix C for zones, training areas and restricted areas).
- c. Season: The Fort McCoy Archery season dates are September 15 November 15, 2018 (early season) and November 26, 2018 January 6, 2019 (late season).
- (1) The Archery season (to include scouting) is closed in all areas north of Highway 21 during the Gun-Deer Hunt for Hunters with Disabilities on October 6 - 7, 2018.
  - (2) Archery hunting is closed on November 16, 2018 for Gun-Deer season preparations and scouting.
- (3) Archery hunting under the authority of an Archery permit is not allowed on Fort McCoy during the Gun-Deer season (November 17 November 25, 2018). Archery hunting during the Gun-Deer season is only allowed if in possession of a valid Fort McCoy Gun-Deer permit.
- d. Entry and hunting hours: **Entrance into Fort McCoy training areas is not permitted until 5:00 a.m. each day**. Reference 2018 State of Wisconsin Deer Hunting Regulations for legal hunting times.
- e. Weapons: The use of crossbows is only authorized within regular Archery training areas on Fort McCoy. Crossbows are not authorized within Cantonment Archery hunting areas. Individuals hunting with both bow and/or crossbow must have the appropriate Wisconsin Deer Archer/Crossbow License upgrade.
- f. Harvest limit: **Harvest is limited to one deer** (antlered **or** antlerless) with the purchase of the 2019 Fort McCoy Archery permit. The Fort McCoy Archery Either Sex harvest authorization is included in the

sale of the Fort McCoy Archery permit and will be issued to the hunters iSportsman account. An additional antlerless deer can be harvested if the Fort McCoy Archery Bonus Antlerless harvest authorization is also purchased, limit of one Fort McCoy Archery Bonus Antlerless harvest authorization per hunter on a first come, first serve basis. Information regarding the availability of Fort McCoy Bonus Antlerless Archery Tags (purchased bonus tag) will be posted on iSportsman or through the PSO. **WDNR issued deer tags/harvest authorizations are not valid on FortMcCoy**.

- g. Tree stands: Refer to paragraph 2-2p for rules and regulations regarding the use of tree stands.
- h. Hunting blinds: Refer to paragraph 2-2q for rules and regulations regarding the use of hunting blinds.
- i. Deer drives and group hunting: Refer to paragraph 2-2u for rules and regulations regarding deer drives and group hunting.
- j. Registration and reporting: Fort McCoy has established online and phone-in registration procedures for the Archery season through the Fort McCoy iSportsman system. Fort McCoy Archery hunters are required to report/register their harvested deer during the iSportsman check-out process. Hunters may be asked to provide a confirmation number by state law enforcement or meat processors, the confirmation number will NOT be provided during the check-out process and is the hunters' responsibility to create the confirmation number. The confirmation number will be made up of the hunters six digit Fort McCoy permit number (XXXXXX) and six digit date of harvest/registration (MMDDYY). The confirmation number will be 12 digits long and in the format described above (XXXXXX-MMDDYY). Once your Fort McCoy harvest is reported through iSportsman your registration is complete and there is NO Requirement to also report your harvest through the WNDR registration system.
- k. Once an archer has harvested a deer, the archer can continue to hunt small game using blunt tipped or judo point arrows. Upon harvesting a deer, archers cannot have broad heads in their possession except during the Fall Turkey season, if they have a valid Fort McCoy Fall Turkey permit, or if they possess an additional valid Archery deer tag. **Archers are not allowed to shoot deer for another archer.**
- I. Restricted archery areas: Reference appendix C for area restrictions. When hunting in areas around the Sparta/Fort McCoy Airport, hunters are not allowed to cross the fence surrounding the runways. Call the Fort McCoy Police at (608) 388-2266 if a wounded deer enters the airport area.

#### **3-4. Cantonment Archery Regulation:** reference appendix F for map.

- a. Permits: A Fort McCoy Cantonment Archery permit and Wisconsin Archery license or Archer Upgrade is required to hunt on Fort McCoy. The Wisconsin Deer Crossbow hunting license is not valid within the Cantonment Area. The procedure to apply for a Fort McCoy Cantonment Archery permit (and carcass tags) is outlined under paragraph 2-2c(3). Applicants may be required to provide information for a full background check before they can access the Cantonment Area.
- b. Sign-in/sign-out: All Cantonment Archery hunters must select Cantonment Archery as the hunting activity and are required to sign-in and sign-out daily through iSportsman, reference paragraph 2-2i(1) for sign-in/sign-out procedures. The iSportsman system can be accessed by: calling (866) 277-1597, visiting <a href="www.mccoy.isportsman.net">www.mccoy.isportsman.net</a> online, or at the kiosk located at the HIP (see map at appendix F for Cantonment Archery hunting areas).
- c. Season: The Fort McCoy Cantonment Archery season dates are September 15 November 15, 2018 (early season) and November 17, 2018 January 6, 2019 (late season).
- (1) Cantonment Archery hunting is closed on November 16, 2018 for Gun-Deer season preparations and scouting.
- (2) Cantonment archery season will remain open during the Gun-Deer Hunt for Hunters with Disabilities on October 6 7, 2018 and the Gun-Deer season on November 17-26, 2018. **Blaze**

orange/pink is required in Training Areas D-10W, D-10E, and G-1 on October 6 - 7, 2018.

- d. Entry and hunting hours: **Entrance into Cantonment hunting areas is not permitted before 5:00 a.m. each day.** Reference 2018 State of Wisconsin Deer Hunting Regulations for legal hunting times.
- e. Weapons: Bow and arrow is the only approved weapon within designated Cantonment Archery areas. Crossbows are not authorized for the Cantonment Archery hunt.
  - f. Tree stands: Refer to paragraph 2-2p for rules and regulations regarding the use of tree stands.
- g. Deer drives: Deer drives are prohibited in the Cantonment Area and Cantonment Archery areas.
- h. Harvest limit: Two Fort McCoy Cantonment Archery harvest authorizations are issued with the purchase of the Fort McCoy Cantonment Archery permit. The harvest authorizations allow the archer to shoot a spike buck or antierless deer. Archers with a Fort McCoy Cantonment Archery Permit are allowed to use their Cantonment Archery harvest authorizations only in specified areas as identified on the Fort McCoy Cantonment Archery Map (reference appendix F). Archers may be required to verify the harvest site.
- (1) A limited number of special (bonus) tags may be available on a first-come, first-served basis to hunt after harvesting a deer in the Cantonment Area. Requests can be made to the PSO upon presenting their deer registration confirmation numbers for their Cantonment Archery deer harvest(s).
- (2) **Earn-a-buck:** An antlered deer can be harvested in the Cantonment Area, but only after 2 antlerless/spike deer have been harvested. The Earn-a-buck authorization will be issued through the PSO after confirmation that two antlerless/spike deer have been harvested in the Cantonment Area. Any antlered deer harvested must be tagged using the 2018 WDNR Archery Buck Tag.
- i. Registration and reporting: Fort McCoy has established online and phone-in registration procedures for the Archery season through the Fort McCoy iSportsman system. Fort McCoy Cantonment Archery hunters are required to report/register their harvested deer during the iSportsman check-out process. Hunters may be asked to provide a confirmation number by state law enforcement or meat processors, the confirmation number will NOT be provided during the check-out process and is the hunters' responsibility to create the confirmation number. The confirmation number will be made up of the hunters six digit Fort McCoy permit number (XXXXXX) and six digit date of harvest/registration (MMDDYY). The confirmation number will be 12 digits long and in the format described above (XXXXXX-MMDDYY). Once your Fort McCoy harvest is reported through iSportsman your registration is complete and there is NO Requirement to also report your harvest through the WNDR registration system.
  - j. Vehicles are only allowed on established roads and trails.
- k. Hunters in the Cantonment Area are not allowed to shoot at deer that are outside wooded areas (i.e., a deer standing in the open on a parade field).
- I. Hunters in the Cantonment Area are not allowed to walk outside of the hunting areas in an attempt to chase deer into the hunting areas.
  - m. Hunters in the Cantonment Area must field dress deer in wooded areas only.
- n. The Cantonment Area may be closed at any time during the season. The Game Line will inform hunters in the event an area is closed to hunting.
- o. Any violation associated with the Cantonment Archery season regulation will subject the individual to **permanent revocation** of Cantonment Archery hunting privileges and may include additional revocation of privileges, to include hunting, fishing, trapping, firewood cutting, and non-hunting/fishing activities.

## **3-5. Gun-Deer Regulation**: refer to appendix D for map.

- a. Permits: A Fort McCoy Gun-Deer permit **and** Wisconsin Gun-Deer hunting license are required to participate during the Gun-Deer season on Fort McCoy. The procedure to apply for a Fort McCoy Gun-Deer permit is outlined under paragraph 2-2c(3). Permit holders wishing to bring a non-hunting guest to accompany them on a deer hunt must use iSportsman to sign-in the individual as a Guest. Non-hunting guests may not participate in the hunt or deer drives.
- b. Sign-in/sign-out: All Gun-Deer hunters must select the zone they intend to hunt and are required to sign-in and sign-out daily through iSportsman, reference paragraph 2-2i(1) for sign-in/sign-out procedures. The iSportsman system can be accessed by: calling (866) 277-1597, visiting <a href="https://www.mccoy.isportsman.net">www.mccoy.isportsman.net</a> online, or at the kiosk located at the HIP (see map at appendix D for zones, training areas and restricted areas).
  - c. Seasons: The Fort McCoy Gun-Deer season dates are November 17 November 25, 2018.

Hunters are reminded that Fort McCoy operational requirements may require closing the season early.

d. Entry and hunting hours: **Hunters may enter the training areas no earlier than 2:00 a.m. each day. All hunters must be out of all training areas by 6:30 p.m.** If tracking a wounded deer will result in the hunter not able to exit the training area by 6:30 p.m., you must call the Fort McCoy Police at (608) 388-2266 before 6:30 p.m. to obtain authorization to remain in the training area.

- e. Harvest limit: **Harvest is limited to one antlered deer** with the purchase of the awarded 2019 Fort McCoy Gun-Deer Permit. The Fort McCoy Gun-Deer Antlered harvest authorization is included in the sale of the Fort McCoy Gun-Deer permit and will be issued to the hunters iSportsman account. **WDNR issued deer tags/harvest authorizations are not valid on Fort McCoy.**
- (1) Fort McCoy is a separate Deer Management Unit and issues Hunter Choice Approval's (HCA). A HCA validation does not represent a bonus deer harvest authorization. Individuals have the choice to apply for the Fort McCoy HCA after receiving notification that the hunter was awarded the Fort McCoy Gun-Deer Permit. Individuals that apply and are awarded the Fort McCoy HCA, can harvest one deer of either sex at any time during the Gun-Deer season, as long as the hunter has a valid/unused Fort McCoy Gun-Deer Antlered harvest authorization.
- (2) An **additional** antlerless deer can be harvested with the purchase of the Fort McCoy Gun-Deer Bonus Antlerless harvest authorization. The Fort McCoy Gun-Deer Bonus Antlerless harvest authorization is limited to one per hunter, and available on a first come, first serve basis. Information regarding the availability and purchase of the Fort McCoy Gun-Deer Bonus Antlerless harvest authorizations will be available at the PSO and the iSportsman website, <a href="www.mccoy.isportsman.net">www.mccoy.isportsman.net</a>, prior to the Gun-Deer season

f. Registration and reporting: All deer harvested during the Gun-Deer season, before leaving the installation, must be brought to the Deer Data Collection Point (DDCP) for collection of biological data by Fort McCoy Wildlife staff. The DDCP (adjacent to the HIP), will be the only location open daily starting at 7:00 a.m. and will close two hours after the close of legal hunting hours during opening weekend and one hour after the close of legal hunting hours during the remainder of the

season. Fort McCoy has established online and phone-in registration procedures for the Gun-Deer season through the Fort McCoy iSportsman system. Fort McCoy Gun-Deer hunters are required to report/register their harvested deer during the iSportsman check-out process. Hunters may be asked to provide a confirmation number by state law enforcement or meat processors, the confirmation number will NOT be provided during the check-out process and is the hunters' responsibility to create the confirmation number. The confirmation number will be made up of the hunters six digit Fort McCoy permit number (XXXXXX) and six digit date of harvest/registration (MMDDYY). The confirmation number will be 12 digits long and in the format described above (XXXXXX-MMDDYY). Once your Fort McCoy harvest is reported through iSportsman your registration is complete and there is NO Requirement to also report your harvest through the WNDR registration system.

- g. Weapons: Some training areas have restricted weapon use requirements, reference appendix D. Violators of these restrictions are subject to prosecution under applicable State laws and/or this regulation. Firearms, crossbows, and bows as outlined in the State of Wisconsin Deer Hunting Regulations may be used during the Gun-Deer season, except that the use of crossbows and bows are only allowed on Fort McCoy during the Gun-Deer season(s) as long as the hunter is wearing blaze orange/pink and is using this equipment under the authority of a Fort McCoy Gun-Deer permit and Wisconsin Gun-Deer license. Archery permits and harvest authorities cannot be used during the Gun-Deer season.
  - h. Tree stands: Refer to paragraph 2-2p for rules and regulations regarding the use of tree stands.
- i. Hunting Blinds: Refer to paragraph 2-2q for rules and regulations regarding the use of hunting blinds.
- j. Deer drives: Refer to paragraph 2-2u for rules and regulations regarding deer drives.
- k. Group hunting: Once a hunter has harvested a deer, he or she may continue to hunt for the remainder of the season, but must abide by the Wisconsin Group Hunting Regulation with the exception that ALL hunters participating in deer drives on Fort McCoy must possess a valid Fort McCoy Gun-Deer hunting permit.
- I. Hunting of other species: All other hunting seasons, as outlined in this regulation, are closed on Fort McCoy during the Gun-Deer season. **Coyote hunting is not allowed during the Gun-Deer season.**

#### 3-6. Gun-Deer Hunt for Hunters with Disabilities Regulation: refer to appendix D for map.

- a. Permits: A Fort McCoy Gun-Deer Hunt for Hunters with Disabilities permit, WDNR Disabled Permit (Class A, Class B, Class C, or Class D hunting), **and** Wisconsin Gun-Deer hunting license are required. To be eligible under a Class B permit classification, the permit must be valid for longer than one year **and** allow shooting from a stationary vehicle. The procedure to apply for a Fort McCoy Gun-Deer Hunt for Hunters with Disabilities permit is outlined under paragraph 2-2c(3).
- b. Sign-in/sign-out: All Gun-Deer Hunt for Hunters with Disabilities participants must select the zone they intend to hunt and are required to sign-in and sign-out daily through iSportsman, reference paragraph 2-2i(1) for sign-in/sign-out procedures. The iSportsman system can be accessed by: calling (866) 277-1597, visiting <a href="https://www.mccoy.isportsman.net">www.mccoy.isportsman.net</a> online, or at the kiosk located at the HIP (see map at appendix D for zones, training areas and restricted areas).
- c. Seasons: The Fort McCoy Gun-Deer Hunt for Hunters with Disabilities will be conducted on October 6 7, 2018 on North Post ONLY (north of Highway 21).
- d. Entry and hunting hours: **Entrance into Fort McCoy training areas is not permitted until 5:00 a.m. each day.** Reference 2018 State of Wisconsin Deer Hunting Regulations for legal hunting times.
- e. Weapons: Some training areas have restricted weapon use requirements (reference appendix D). Violators of these restrictions are subject to prosecution under applicable State laws and/or this regulation. Use of all firearms, crossbows, and bows are outlined in the State of Wisconsin Deer Hunting Regulations for use during the Gun-Deer season(s), except that the use of crossbows and bows are allowed on Fort McCoy during the Gun-Deer season(s) as long as the hunter is wearing blaze orange/pink and is using this equipment under the authority of a Fort McCoy Gun-Deer Hunt for Hunters with Disabilities permit and Wisconsin Gun-Deer license.
- f. Harvest limit: Harvest is limited to two deer with the purchase of the 2019 Fort McCoy Gun-Deer for Hunters with Disabilities permit. The two harvest authorizations (one either sex harvest authorization and one antlerless harvest authorization) are included in the sale of the Fort McCoy Gun-Deer Hunt for Hunters with Disabilities permit and will be added to the hunters iSportsman account after the purchase of

the permit. WDNR issued deer tags/harvest authorizations are NOT valid on Fort McCoy.

- g. Hunting areas: Training areas open to hunting will be located on North Post (north of Highway 21). **South Post (south of Highway 21) is closed to Gun-Deer Hunt for Hunters with Disabilities participants.** Appendix D shows overall training areas as referenced on the Game Line at (866) 277-1597 or online at <a href="www.mccoy.isportsman.net">www.mccoy.isportsman.net</a>. Hunters must ensure that the training areas they intend to hunt, are open on the Game Line listing daily.
- h. Registration and reporting: Before leaving Fort McCoy, all deer harvested during the Gun-Deer Hunt for Hunters with Disabilities season must be brought to the Deer Data Collection Point (DDCP) for collection of biological data by Fort McCoy Wildlife staff. The DDCP (adjacent to the HIP), will be the only location open daily starting at 7:00 a.m. and will close one hour after the close of legal hunting hours. Fort McCoy has established online and phone-in registration procedures for the Gun-Deer for Hunters with Disabilities season through the Fort McCoy iSportsman system. Fort McCoy Gun-Deer for Hunters with Disabilities participants are required to report/register their harvested deer during the iSportsman check-out process. Hunters may be asked to provide a confirmation number by state law enforcement or meat processors, the confirmation number will NOT be provided during the check-out process and is the hunters' responsibility to create the confirmation number. The confirmation number will be made up of the hunters six digit Fort McCoy permit number (XXXXXXX) and six digit date of harvest/registration (MMDDYY). The confirmation number will be 12 digits long and in the format described above (XXXXXXX-MMDDYY). Once your Fort McCoy harvest is reported through iSportsman your registration is complete and there is NO Requirement to also report your harvest through the WNDR registration system.
- i. Hunter briefings: Individuals selected for the Gun-Deer Hunt for Hunters with Disabilities season are required to attend an informational and safety briefing. Information will be provided to permit holders, including information on scheduling a briefing, through the awarded permit notification letter before the start of the hunt.
- j. Hunting of other species: All other hunting seasons are closed on North Post during the Gun-Deer Hunt for Hunters with Disabilities season. **Coyote hunting is not allowed.**
- k. Hunting blinds: Refer to paragraph 2-2q for rules and regulations regarding the use of hunting blinds.
  - I. Deer drives: Refer to paragraph 2-2u for rules and regulations regarding deer drives.
- m. Group Hunting: Once a hunter has harvested a deer, he or she may continue to hunt for the remainder of the season, but must abide by the Wisconsin Group Hunting Regulation with the exception being that **ALL** hunters participating in deer drives on Fort McCoy must possess a valid Fort McCoy Gun-Deer hunting permit.

#### **3-7. Spring Turkey Regulation:** refer to appendix C for map.

- a. Permits: A Fort McCoy Spring Turkey hunting permit, the appropriate Wisconsin hunting license (i.e., current Spring Turkey Hunting License, Conservation Patron License or a Senior Citizen Recreation Card), and Wild Turkey Stamp are required. Conservation Patron License and Senior Citizen Cardholders are exempt from the stamp requirement. The procedure to apply for a Spring Turkey hunting permit is outlined under paragraph 2-2c(3). All persons must reference the 2019 Wisconsin Spring Turkey Hunting Regulations for additional license information. Fort McCoy is a separate unit and is not part of Zone 1. Wisconsin Spring Turkey Permits for Zone 1 are not valid on Fort McCoy.
- b. Sign-in/sign-out: All Spring Turkey hunters must select the zone they intend to hunt and are required to sign-in and sign-out daily through iSportsman, reference paragraph 2-2i(1) for sign-in/sign-out procedures. The iSportsman system can be accessed by: calling (866) 277-1597, visiting <a href="https://www.mccoy.isportsman.net">www.mccoy.isportsman.net</a> online, or at the kiosk located at the HIP (see map at appendix C for zones, training areas and restricted areas).
- c. Seasons: The Spring Turkey seasons on Fort McCoy consists of six separate hunting periods, commencing on the opening day of the Wisconsin Spring Turkey season. The first period consists of Wednesday, Thursday and Friday, and the following five weekly periods are Monday Friday. Hunting is not allowed on weekends. Fort McCoy does not offer a Youth Turkey Hunt Season, as it falls on a weekend.
- d. Entry and hunting hours: **Entrance into Fort McCoy training areas is not permitted until 4:00 a.m. each day.** Reference State of Wisconsin Spring Turkey Hunting Regulations for legal hunting

times.

- e. Harvest limit: Harvest is limited to one bearded turkey with each purchase of a 2019 Fort McCoy Spring Turkey permit. The Fort McCoy Spring Turkey harvest authorization is included in the sale of the Fort McCoy Spring Turkey permit and will be issued to the hunters iSportsman account after the permit is purchased. After the quota lottery drawing has been completed, any remaining Fort McCoy Spring Turkey permits will go on sale on a first come, first serve basis. Information regarding the availability and purchase of the Fort McCoy Spring Turkey harvest authorizations will be available at the PSO and the iSportsman website, <a href="www.mccoy.isportsman.net">www.mccoy.isportsman.net</a>, prior to and during the Spring Turkey season. WDNR issued Spring Turkey harvest authorizations are not valid on Fort McCoy.
- f. Registration and reporting: Fort McCoy has established online and phone-in registration procedures for the Spring Turkey season through the Fort McCoy iSportsman system. Fort McCoy Spring Turkey hunters are required to report/register their harvested turkey during the iSportsman check-out process. Hunters may be asked to provide a confirmation number by state law enforcement or meat processors, the confirmation number will **NOT** be provided during the check-out process and is the hunters' responsibility to create the confirmation number. The confirmation number will be made up of the hunters six digit Fort McCoy permit number (XXXXXXX) and six digit date of harvest/registration (MMDDYY). The confirmation number will be 12 digits long and in the following format (XXXXXX-MMDDYY. **Once your Fort McCoy harvest is reported through iSportsman your registration is complete and there is NO Requirement to also report your harvest through the WNDR registration system.**
- g. Hunting blinds: Refer to paragraph 2-2q for rules and regulations regarding the use of hunting blinds.

#### **3-8. Trapping Regulation**: refer to appendix G for map.

- a. Permits: A Fort McCoy Trapping permit **and** Wisconsin Trapping license are required to trap on Fort McCoy. The procedure to apply for a Fort McCoy Trapping permit is outlined under paragraph 2-2c(3).
- b. Sign-in/sign-out: All trappers must select the zone they intend to trap and are required to sign-in and sign-out daily through iSportsman, reference paragraph 2-2i(1) for procedures regarding sign-in/sign-out and switching zones. The iSportsman system can be accessed by: calling (866) 277-1597, visiting <a href="www.mccoy.isportsman.net">www.mccoy.isportsman.net</a> online, or at the kiosk located at the HIP (see map at appendix G for zones, training areas and restricted areas).
- c. Season: The Fort McCoy Trapping seasons and dates coincide with the State of Wisconsin Trapping seasons and dates. Trappers are reminded that, due to furbearer management goals, seasons may be closed at any time.
- (1) The trapping season (to include scouting) is closed in all areas north of Highway 21 during the Gun-Deer Hunt for Hunters with Disabilities on October 6 - 7, 2018.
- (2) Trapping is not allowed on Fort McCoy during the Gun-Deer season (November 17 November 25, 2018).
- d. Registration and reporting: Trappers will furnish NRB Wildlife with a map depicting the general location of traps and the number of traps set at the start of their trapping. An updated map must be provided if any traps are moved or added throughout the trapping season. Trappers will furnish an annual harvest report to the NRB Wildlife Program at the end of the trapping season. Trapping reports and maps can be dropped off at the trapping drop-box located at the HIP or at the PSO. Additional information or data may also be required from trappers. The WDNR has established online and phone-in registration procedures for the Trapping season. All bobcat, fisher, and otter need to be registered through the WDNR GameReg system. Trappers must follow the WDNR guidelines described in the State of Wisconsin Trapping Regulations. When registering your harvest through the WDNR GameReg process, select Fort McCoy as your trapping unit and Monroe as the county of harvest.
  - e. All leg hold traps (wet or dry) will be checked on a daily basis.
  - f. Coyote sets are limited to #2 offset coil spring traps or smaller.
- g. No more than 75 traps will be set at one time by each permitted trapper, unless specifically authorized by the NRB Wildlife Program.
- h. Cantonment Raccoon Trapping: One trapper will be allowed to trap raccoon in specific areas within the Cantonment Area. A drawing will be held to determine who will be allowed to trap in these specified areas. Additional regulations will apply to these areas.

- **3-9. Fishing Regulation**: refer to appendix E for map.
- a. Categories and fees: All persons fishing on Fort McCoy are required to have a Fort McCoy Fishing permit <u>and</u> appropriate Wisconsin Fishing license. Wisconsin residents 65 and over, persons with disabilities (as determined by applicable Wisconsin law), children under age 16 fishing independently, and 4-day residents/nonresidents, may purchase a reduced fee permit. Children under age 16 do not require a Fort McCoy Fishing permit if fishing with someone who has a Fort McCoy Fishing permit and Wisconsin fishing license (with trout stamp if fishing for trout). However, fish caught by children under age 16 who do not have a Fort McCoy Fishing permit must be included in the accompanying Fort McCoy and Wisconsin licensed angler's daily bag limit. The procedure to purchase a Fort McCoy Fishing permit is outlined under paragraph 2-2c(1).
- b. Expiration: All Fishing permits expire **March 31**. Permit expiration coincides with annual Wisconsin Fishing License expiration. Fishing permits are non-transferable and non-refundable.
- c. Sign-in/sign-out: Starting on March 1, 2019 all anglers must sign-in/sign-out daily and select the zone they intend to fish through iSportsman, reference paragraph 2-2i(1) for procedures regarding sign-in/sign-out and switching zones. The iSportsman system can be accessed by: calling (866) 277-1597, visiting <a href="www.mccoy.isportsman.net">www.mccoy.isportsman.net</a> online, or at the kiosk located at the HIP (see map at appendix E for zones, training areas, lakes and restricted areas).
- d. Seasons and dates: Unless otherwise posted, fishing, including trout, is permitted on all lakes and ponds from the first Saturday in May through the first Sunday in March. The North Flowage and Lost Lake are open for panfish all year. Fishing on streams is permitted from the first Saturday in May through 15 October. Fort McCoy streams will be open for the early catch and release trout season as explained in the Wisconsin Trout Fishing Regulations and Guide.
- (1) Fishing is closed in all areas north of Highway 21 during the Gun-Deer Hunt for Hunters with Disabilities on October 6 7, 2018.
- (2) Fishing is not allowed on Fort McCoy during the Gun-Deer season (November 17 November 25, 2018).
  - e. Access to waters:
- (1) Lakes: If a lake is listed as open on the Game Line, but is within a closed training area and military training is not taking place at the lake, anglers can utilize the marginal area around the lake (i.e., mowed area or 50 feet from shore if the lake perimeter is not mowed) that will not conflict with military training, as well as access the lakes by the main access road(s). Anglers are responsible for knowing if the lakes are closed due to training, this can be checked on the iSportsman Game Line posting.
- (2) Streams: If a stream runs through a training area, or is used as a boundary of the training area, and the training area(s) are closed for the day, anglers can still access and fish those streams; but must do so by staying within the stream corridor/floodplain, avoiding military training, and accessing those streams at main road crossings. An angler is not allowed to walk/drive through a closed training area to access streams. Parking of vehicles to access those streams should occur at main road/stream crossings. Silver Creek has a designated parking area along the main road in B-2, refer to the Fishing Map in appendix E. Anglers are responsible for knowing if the training areas are closed due to training, this can be checked on the iSportsman Game Line posting.
- f. Ice fishing: Anglers may fish through the ice on all lakes/ponds at their own risk. Ice shanties can be used on lakes/ponds, but must be removed at the end of each day.
- g. Bag, possession, and size limits: Bag, possession, and size limits on any Fort McCoy lakes, ponds, rivers and streams not listed below follow the State of Wisconsin Fishing Regulations. Once you reach any of these limits for a particular species, you must stop fishing for that species.
- (1) Possession limit means the maximum number of fish that a person may possess or control (i.e., in your freezer, cooler, vehicle, etc.), which is twice the total daily bag limit.
- (2) Total daily bag limit is the maximum number of fish that an angler may possess from all water bodies fished for that day.

\*Panfish are defined as the following species: bluegill, pumpkinseed, black and white crappies, yellow perch, green sunfish, warmouth, and sunfish.

(3) Daily bag limit is the maximum number of fish that an angler may possess from a specific water body in one day. An angler may not possess in excess of the daily bag limit for the water while on the waters, banks or shores of that water.

- (4) Early trout: The daily bag limit and possession limit for early trout season is zero.
- (5) Fish caught by children under 16 years old who do not possess a Fort McCoy permit are included in the accompanying Fort McCoy and Wisconsin licensed angler's daily bag limit.
- h. Silver Creek: Only artificial lures may be used on Silver Creek from the bridge east of the airport, downstream to the western boundary of Fort McCoy. This section is highlighted on the Fort McCoy Fishing Map (refer to appendix E).
- i. Boats and motors: Operation of gasoline motors is prohibited on all Fort McCoy waters with the exception of emergency first responders or Fort McCoy employees in performance of their official duties. Boats, canoes, kayaks, and floats with or without electric trolling motors are allowed only on the North Flowage, Lost Lake, West Sandy, Sandy, Big Sandy, Suukjak Sep, and East Silver Lakes. Boats, canoes, kayaks, and floats are **NOT** allowed on Stillwell Lake, Swamp or Sparta Ponds. All Boats, canoes, kayaks, and floats on Fort McCoy waters must comply with Wisconsin Boating Regulations. All privately owned watercraft must be removed from Fort McCoy property at the end of each day.
- j. Minnows and crayfish: Legal minnows may **ONLY** be used in the North Flowage and Lost Lake. Other than the North Flowage and Lost Lake, minnows dead or alive (except commercially preserved) are not allowed as bait or to be in an angler's possession at any time. Crayfish are not allowed as bait on **any** Fort McCoy waters. It is not permitted to release unused bait fish into any Fort McCoy waters. Follow Wisconsin Minnow and other Baitfish Regulations regarding the purchase and transportation of minnows.
- k. Fishing methods: It is illegal to fish with nets, seines, and spears (including bow and arrow, crossbow, or by hand) on Fort McCoy waters.
- I. Swimming/Wading: Swimming/wading is not allowed on Fort McCoy, except at the Pine View Recreation Area Beach, unless wading is being used while in the act of fishing.
- m. Unauthorized stocking: It is illegal to transplant live fish from one water body to another without the consent of Fort McCoy NRB Fisheries Program. **DO NOT move**, release, or stock fish, including minnows, into Fort McCoy waters.

#### 3-10 Non-Hunting/Fishing Activities Regulation: refer to appendix E for map

a. Permits: A Fort McCoy Access Pass is required by recreational users for the Non-Hunting/Fishing

activities. A Fort McCoy Access Pass is issued online through the iSportsman system for each individual account and needs to be updated/renewed on an annual basis.

- b. iSportsman Account: Individuals are required to have an account in iSportsman before they can engage in non-hunting/fishing activities.
- c. Sign-in/sign-out: All individuals participating in non-hunting/fishing activities must select the zone they intend to enter and are required to sign-in and sign-out daily through iSportsman, reference paragraph 2-2i(1) for procedures regarding sign-in/sign-out and switching zones. The iSportsman system can be accessed by: calling (866) 277-1597, visiting <a href="https://www.mccoy.isportsman.net">www.mccoy.isportsman.net</a> online, or at the kiosk located at the HIP (refer to Fishing map in appendix E for zones, training areas, and restricted areas).
- d. Area closures: The Game Line, accessed by calling (866) 277-1597, online at <a href="https://www.mccoy.isportsman.net">www.mccoy.isportsman.net</a>, or at the kiosk at the HIP, lists training areas that are closed on any particular day. The Game Line listing will be updated by DPTMS. Fort McCoy reserves the right to update hunting area closures at any time if needed. ALL users are required to call the Game Line daily for any changes.
  - e. Allowable Activities (all activities are prohibited during the Gun-Deer season):
  - (1) Berry picking
  - (2) Mushroom hunting
  - (3) Deer antler shed hunting
  - (4) Watercress harvesting
  - (5) Fern fiddlehead collection
  - (6) Bird watching
  - (7) Dog walking
  - (8) Nature photography
  - (9) Walking/Hiking
  - (10) Biking/Mountain biking on established roads/trails only.
  - (11) If an activity is not listed here, contact the NRB for approval.
- f. Collecting of items is limited to amounts for personal use and consumption. **Collection for sale or commercial use is strictly forbidden.**


# Appendix B Suspension/Revocation of Fort McCoy Game Privileges





Small Game, Archery & Turkey Hunting Map

















Appendix F Fort McCoy Cantonment Archery Map
